# 1. KEY ISSUES

2.5 The Trust Board is asked to commend the winners and to record its thanks to all those who helped to make the event such a success, including the panel of judges.

# 3. THE MID STAFFORDSHIRE NHS FOUNDATION TRUST PUBLIC INQUIRY

- 3.1 On 19<sup>th</sup> September 2012, Robert Francis QC, Chairman of the Mid Staffordshire NHS Foundation Trust public inquiry, announced an update to his expected timetable.
- 3.2 It had been anticipated that the Inquiry report would be published in October 2012.
- 3.3 The Chairman announced that he now hopes to deliver his final report to the Secretary of State for Health by early January 2013, when Parliament returns from its recess.

### 3.4 Robert Francis QC said:

"The Inquiry has heard a huge amount of evidence from many witnesses and organisations, and has gathered information from a number of seminars and visits. In addition, I need to complete a number of formal processes, to ensure any conclusions and

recommendations I produce are fair and constructive. Pulling this together into the final report is a complex and sensitive process.

In order to ensure thorough consideration of these matters, I have written to the Secretary of State for Health to inform him that I now plan to complete my work in time to deliver my report to him by early January 2013.

As before, I am making this information publicly available, so that core participants, witnesses and those following the Inquiry are fully aware of the Inquiry's progress."

3.5 A report will be submitted to the Trust Board on the eventual publication of the Inquiry report.

## 4. ANNUAL PUBLIC MEETING 2012

- 4.1 At the time of writing this report, the Trust had yet to hold its Annual Public Meeting 2012.
- 4.2 This is to take place on Saturday, 22<sup>nd</sup> September 2012 at the Leicester Royal Infirmary, following a health fair (including historical tours).
