Executive Summary

Context

This paper provides the Trust Board with a status on the campaign to retain the East Midlands Congenital Heart Centre at UHL.

Questions

1. What impact has the announcement of the General Election had on the campaign?

3. What is the approval process for the Trust formal response to the consultation?

Conclusion

1. The announcement of a General Election on June 8th requires all public sector services to respect a 6 week purdah period prior to the election. Due to this all public communications in relation to the Congenital Heart Disease consultation will be limited, no stakeholder meetings will be held, and all planned consultation meetings with NHS England have been postponed until after the election.
2. The Growth Plan which details the UHL strategy to meet the only outstanding standard needed for full compliance to the CHD standards was sent to NHS on the 3rd May 2017. The planned meeting to review the growth plan with NHS England has been postponed due to purdah; we are awaiting a date for the meeting post General Election.
3. The Trust formal response to the consultation questions has been drafted and will shortly be out for comment from stakeholders. It will be presented to the Executive Performance Board on the 27th June 2017 and the Trust Board on the 6th July.
