UHL R&I QUARTERLY TRUST BOARD REPORT January 2023

1. INTRODUCTION

This report describes UHL R&I activities, performance and delivery in the last few months.

2. RESEARCH PERFORMANCE

2.1 Recruitment into CRN Portfolio Studies

Since the last R&I report in October 2022 there is some legacy COVID-19 urgent public health research activity, but other study activity continues to move back towards business as usual.

2.2 Performance Analysis

Compared to 2021/22, current trial recruitment is approximately 1000 recruits less at end November 2022 and thus the trend is towards lower recruitment overall for 22/23.

- i. The major contributing factor is that some of the highest recruiting studies have finished and ceased recruiting.
- ii. We are ahead of usual performance in commercial research activity having prioritised this as requested by NIHR.
- iii. As a consequence of ii, there has been a decreased emphasis on high volume observational studies
- iv. There is a 'tail' of COVID study follow-ups that continue to consume resources.
- v. There is a natural reduction in recruitment cycle over the 5 years of NIHR Infrastructure as the current funding cycle closes out.

2.3 CRN Infrastructure Budget 2023-24

Confirmation has been received from CRN that the 2023-24 infrastructure budget for UHL will be £4.047.147.

This represents an uplift of ~£2.54% compared to the previous year.

3.0 CANCER STUDIES AT UHL

- 3.1 The Hope Against Cancer-funded extension to the Hope Cancer Trials Centre at Leicester Royal Infirmary is now fully operative.
- 3.2 Mehmooda Duke MBE DL, the High Sheriff of Leicestershire, visited the Hope Cancer Trials Centre and Leicester Cancer Research Centre in Dec 2022. She said:

"It was wonderful to meet staff, including the nursing staff who look after some of the patients undergoing clinical trials with such kindness and compassion, the research scientists, the team in the Hope office, the data collection and analysts, and PhD students who are funded by Hope Against Cancer."

We will be joined by Dr Harriet Walter, Consultant Clinical Oncologist who will give an update on the exciting new cancer research studies at UHL.

4.0 UHL MONTHLY RESEARCH BULLETINS

- 4.1 We produce a monthly UHL Research and Innovation Bulletin that is widely distributed. The October 2022 bulletin is attached for information (appendix 1).
- 4.2 The following annual achievements are highlighted in the December 2022 UHL Research Bulletin:
 - A £26 million NIHR Biomedical Research Centre, complete with three new themes - personalised cancer prevention and treatment, environmental health
 - A £4.1 million NIHR Clinical Research Facility, representing a three-fold increase in funding compared to the previous funding round
 - Excellent recovery of our commercial research portfolio

- A contract extension for our NIHR Participant Recruitment Centre until March 2024
- Delivering an 'Inclusive Research and Innovation' Conference in November for 200 delegates
- Opening a 'Hope' balcony at the Leicester Royal Infirmary, where patients on cancer trials can step away from the clinical environment for rest and recuperation
- Approved 155 studies, of which 48 were commercial trials since April 2022
- Creation of the first Shared Decision Making Council in research, set up by the women's health research team (more on this in the next bulletin!)

5.0 OTHER UHL R&I NEWS

5.1 A UHL Research and Innovation Conference entitled 'Inclusive Research and Innovation' was held at the Big Shed on 17th November 2022. Over 200 delegates enjoyed a varied programme over the day. These included senior leaders from UHL, UoL, Loughborough University and University Hospitals of Northamptonshire NHS Group.

5.2 Secure Data Environments for Research (SDE). The LLR-ICB has been awarded funding from NHSE to develop a business case for an East Midlands SDE. UHL will be a leading member of the group working on this project. If successful, this will unlock up to £10M further funding.














Research and Innovation bulletin October 2022

It gives me great pleasure to share that Leicester has been awarded an NIHR Biomedical Research Centre (BRC) to the tune of £26million over the next five years. The official announcement was made on Friday 14 October by the Department of Health and Social Care. Professor Melanie Davies joined Richard Mitchell on the Friday Focus to spread the news. You can read our press release here.

We can also confirm that the contract for the NIHR Patient Recruitment Centre: Leicester (PRC) has been extended until the end of March 2024. The PRC has played a major role in increasing our commercial studies portfolio, as well as delivering a successful vaccine trial during the pandemic.

The closing date for our **Research and Innovation Awards** is tomorrow (Friday 28 October). You can find out all the criteria, categories, and a <u>nomination form on the UHL website</u>. We are not expecting nominators to write extended essays, just a few lines in each section to say why the person or team they are nominating should win an award. Those who are shortlisted, plus their nominator, will be invited to a formal awards ceremony with a 3-course dinner, in January 2023.

We are also counting down the days to our **Research and Innovation Conference**, which will include a celebration of our BRC and Clinical Research Facility (CRF). Research in the news

Time of day matters for breast cancer treatment



Breast shrinkage after breast cancer radiotherapy could be reduced by treating a patient at the optimum time of day, as predicted by their body clock genes.

Scientists and clinicians from the University of Leicester and University Hospitals of Leicester NHS Trust have identified three genes linked to circadian rhythms – our internal body clocks – that are associated with increased risk of side-effects following radiotherapy at particular times in the day.

The results of the study provide more evidence for a personalised approach to radiotherapy, by testing patients for the presence of these three gene variants and then treating them at the optimal time.

Increasing Chief Investigator capacity



NIHR CRN East Midlands has launched a new Health and Care Research Scholars Programme, which aims to increase Chief Investigator capacity across the region.

The new programme - which is taking place as an initial pilot - will see CRN East Midlands support two groups of scholars at a level of up to one day a week (0.2 WTE) for a 12-month period.

The programme is open to applicants from all registered professions.

- 'Research Scholars' applicants will be research active individuals who wish to become Chief Investigators in the future
- 'Advanced Research Scholars' will include those already established as senior researchers and provide protected time to develop new grant applications

Indemnity arrangements in research



Whether research is taking place within NHS premises, patients' homes, care homes, hospices or other spaces in which NHS researchers undertake NHS research, NHS staff are covered by NHS Resolution indemnity schemes. NHS research in England is research that has HRA and HCRW Approval.

Proportionate Review Toolkit

The HRA has published a decision toolkit to help you determine if a research application is eligible for proportionate review by a Research Ethics Committee (REC).

Proportionate review (PR) is a lighter touch review process for research proposals that raise no material ethics issues, but many applications submitted for PR do not meet the criteria and have to be transferred for full REC review. This causes delays to the ethics review for applicants.

The toolkit takes not more than five minutes to complete and will tell you which route to submit your study.
